**Eagle Project Report**

Cody Atwood and Austin Schiefer reported on the progress of their Eagle project. Their project was to replace the cement around the fire pit at the North Park and install 4 benches.

**Minutes**

**Building Permit – Ben Sorensen – 275 East 9200 South – Shed**

The Council looked over the permit for Ben Sorensen and all looked in order. A motion was made by Kyle to approve the permit. Seconded by Don. All in favor. Bev will have Ben fill out the dimensions of the shed when he comes to pick up the permit.

**Bills**

**Unfinished Business** – Chris Wight sent the Town a letter reporting on the progress of the water tank. He has done some of the work for the project. Mayor Howlett invited Chris to come to one of our Council meetings to present his proposal. There was an extensive discussion on the pros and cons of the different proposals.

**Consider park maintenance and snow removal contract**

The Council went over the contract from Star Landscape. It was agreed that they have done a good job maintaining the parks and they are very agreeable to share the snow removal with the Town. A motion was made by Don to approve the contract by Star Landscape. Seconded by Mat. All in favor.

**Fire Department** –Troy reported that Cache County has donated the department a new ambulance. The old ambulance will be donated and sent to Mexico. Lee reported that the title is in the safety deposit box. He will get it to Troy. Blake reported on the CERT training. 10 members started the class and 7 were there for the testing. It was discussed that a new class will be started the first of next year.

### **Executive Meeting - Legal**

A motion was made by Mat to open the executive meeting. Seconded by Don. All in favor. Meeting opens at 8:33 pm.
