The Council discussed adding the Planning and Zoning items to the Agenda. Martell made a motion to amend the Agenda, Larry seconded that motion, all in favor.

Minutes- The Minutes of October 16, 2019 were emailed to all the Council members previous to the meeting. Vic made a motion to approve the Minutes as read; Larry seconded that motion, all in favor.

Bills- Martell read the bills. Martell made a motion to accept the bills as read; Vic seconded that motion, all in favor.

Public Comment- Jack Obray attended the meeting to get some information on his Eagle project, which consists of getting the bleachers set up at the riding arena. Jack was able to obtain one bid for the bleachers; he was waiting on an additional bid. Jack will email the additional bid when he receives it and the Council can then decide how to have Jack move forward with the project.

Open and Public Meetings Act- Alyssa sent a video by Dave Church to all the Council members previous to the meeting. The Council members watched this video then discussed the Act at the meeting. They went over when an Executive Session can be held and for what reasons and other things learned from the video.

P&Z Items-

- **Vikki Pingle- Barn-** Vikki attended the Planning and Zoning meeting held October 24, 2019. Her application was approved. She emailed proof of her water share to the Town Council the night of the meeting and Vic made a motion to approve the Barn contingent on sufficient water shares and proof, Martell seconded that motion, all in favor.
- **Lex Smith- Shop-** Lex attended the Planning and Zoning meeting held October 24, 2019 and his shop application was approved. The Council went over the application. Vic made a motion to approve the shop; Larry seconded that motion, all in favor.
- **Kirk Petersen- Shop-** The Shop application was approved at the Planning and Zoning meeting held October 24, 2019. The Council went over the application.

Martell made a motion to approve the shop; Larry seconded that motion, all in favor.

Council Reports-

- **Roads - Martell Lowe** – There was discussion on 8600 S. and the new construction using the road and some of the shoulder crumbling and needing repaired.
- **Water- Vic Little** – Nothing at this time.
- **Community- Shannon Rasmussen** – Shannon was excused, nothing at this time.
- **Fire/Grants/Budget- Larry Johnson** – Chief Fredrickson attended the meeting to turn in a request for a new brush truck. He included a few bids and different options. The Council will look through the paperwork and address this item at their next meeting. Chief Fredrickson also discussed holding the trap shoot on Saturday November 23 at the Gravel Pits. The Fire Department voted to have Blake Pulsipher purchase a gun for a giveaway and will get the raffle tickets and a flier printed.
